The Merrillville Community School Corporation has scheduled registration dates for kindergarten classes beginning in August 2010. If your child will be five (5) years old on or before August 1, 2010 you are urged to enroll him/her at the school serving your area on the date listed below. The hours will be 8:30 AM-12:00 NOON & 1:00 PM-2:45 PM. We would like to have those families whose last names begin with the letters, A-N to come in the morning and those whose last names begin with O-Z to come in the afternoon. If you find it impossible to register on the date specified, please register at one of the other schools. Because of the immunization restrictions new students will not be able to enroll on the first day of school.

Bring with you:

- **Your child**, for a vision and hearing screening.
- Your child's State Board of Health Birth Certificate (a hospital certificate of birth is NOT acceptable).
- Your child's updated record of immunizations. Immunization, physical and dental forms are available in the main office of all elementary buildings. You may obtain immunizations from your doctor or call the Lake County Board of Health for information at 755-3655.
- If you have legal guardianship of a child, bring a copy of the court issued custodial papers.
- Proof of Residency:
 - Every parent/guardian enrolling a student must provide a driver's license or a state picture identification card with a current address for the school to photocopy.
 - HOMEOWNERS: (3 of the following 4 are required):
 - Indiana driver's license or state ID with current address – Must Provide
 - Utility bills (NIPSCO, water, sewer)
 - Deed, contract or mortgage statement
 - Lake County tax bill
 - RENTERS/LEASERS:
 - Indiana driver's license or state ID with current address – Must Provide
 - Utility bills (NIPSCO, water, sewer)
 - Rent or lease agreement – Must Provide and Include:
 - Parent/guardian name on the agreement
 - School age student on the agreement as tenants
 - Name and phone number of the manager/landlord
 - Beginning and ending date of agreement

Please note that this information is required even if you have other children in our school corporation.
